



## **Medical Release, Liability Waiver, & Terms Agreed to As Part of SLU Registration**

### **MEDICAL RELEASE INFORMATION**

#### **Standard Medical Release (only applies to those that register as singles)**

In case of accident, illness, or other emergency, I request that SLU contact me. If SLU cannot reach a parent/guardian after conscientious effort, I give permission for staff to call paramedics. If a life-threatening emergency exists, I give permission for staff to call paramedics immediately and then contact me as soon as possible thereafter. I authorize and consent to any X-ray examination, anesthetic, medical, dental, or surgical treatment, and hospital care which, in the best judgment of a licensed physician or dentist, is deemed advisable. I agree to assume financial responsibility for expenses incurred as a result of those services being provided. I also agree to be financially responsible for emergency medical transportation.

#### **Adult Medical Release**

The undersigned hereby authorizes treatment by a qualified and licensed medical doctor in the event of a medical emergency which, in the opinion of the attending physician, may endanger the undersigned's life, cause disfigurement, physical impairment, or undue discomfort if delayed, while the undersigned is participating in activities through Student Leadership University.

### **LIABILITY WAIVER INFORMATION**

The undersigned desires to participate in various programs, events, and activities (hereinafter collectively referred to as "Activities") operated by Student Leadership University. The undersigned further understands and acknowledges that you **understand that there is always a possibility of injury or physical harm while participating in such activities.**

- **61-90 days before departure:** 50% of the total cost of the program will be forfeited.
- **Less than 61 days before departure:** 100% of the total cost of the program will be forfeited.

**Transfer Fees:** (you replace current attendee with a new attendee for the same program)

- **120 days or more before departure:** No transfer fee
- **61 to 119 days before departure:** \$50 plus the cost of the airline ticket change (if airline allows change)
- **14 days to 60 days before departure:** \$100 plus cost of the airline ticket change (if airline allows change)
- **13 days and under before departure:** transfer may not be possible due to VISAs and Airline ticket regulations. If transfer is possible, all costs incurred by SLU will be transferred to attendee.

**Payment deadline:** A deposit of \$500 is due at the time of registration. An additional payment of \$750 is due in February. **The final balance is due 90 days prior to departure. Any registration not paid in full by this day will incur a \$25 late fee.**

***All credit card payments will incur a credit card transaction fee. This fee is 2.24% for all credit cards and will be added as a line item and added to your payment at checkout.***

- **13 days and under before departure:** transfer may not be possible due to VISAs and Airline ticket regulations. If transfer is possible, all costs incurred by SLU will be transferred to attendee.

**Payment deadline:** A deposit of \$500 is due at the time of registration. **All remaining balances are due 90 days prior to departure. Any registration not paid in full by this day will incur a \$25 late fee.**

***All credit card payments will incur a credit card transaction fee. This fee is 2.24% for all credit cards and will be added as a line item and added to your payment at checkout.***
